## **Religious Nonprofit Corporation Articles of Incorporation**

**I. The name of the religious nonprofit corporation is:**

Messiah Fund

**II. The name and physical address of the registered agent of the religious nonprofit corporation is:**

**V. This corporation will have members.**

Provisions regarding the distribution of assets upon dissolution are:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes, provided, however, that any such distribution or disposition shall be made to organizations that have purposes substantially comparable to those of Messiah Fund.

The type of business the nonprofit corporation will be conducting is:

Messiah Fund is organized for the purpose of advancing the Kingdom of God by (a) spreading the Gospel, which is the good news of Gods granting of forgiveness of sins and eternal life through Jesus Christ to all those who believe in His name, (b) providing humanitarian relief, particularly to those who are suffering because of their expressed faith in Jesus Christ, and particularly during the time described by Jesus as the great tribulation, and (c) such other means as the Directors may, from time to time, deem appropriate.

**VII. Additional Article:**

The qualifications, number and duties of Members are as follows:

1. Qualifications. Members need not be residents of the State of Wyoming but must be of legal age. Members must be recognized as persons who advocate Jesus Christ, who have been generous in their giving to religious and charitable causes, and whose reputation is such that they could be trusted to faithfully advance the mission of the corporation. Members must subscribed to the Testimony as set forth in these Articles. The

provisions of this Article shall not be amended except upon unanimous vote of the Members.

2. Number. There shall be at least one (1) Member.

3. Duties. The sole responsibility of the Members is to appoint the Directors of the corporation.

**VIII. Additional Article:**

Members shall be selected and their memberships terminated as follows:

1. Initial Members. The Initial Members shall be specified by the Incorporator in the organizational minutes of the corporation. Thereafter, Members shall be elected by a unanimous vote of the Members.

2. Termination of Membership. Each Member shall hold office indefinitely, provided however, that a Member's membership may be terminated upon receipt by the corporation of (i) such Member's resignation, (ii) proof of such Member's death (by presumption or otherwise) or incapacity, (iii) proof of such Member's confession to or conviction of an act involving fraud or theft or constituting a felony, (iv) proof of such Member's renunciation of the Testimony, or (v) proof that such Member is unaccounted for.

**IX. Additional Article:**

Members shall be specially elected by Delegates as follows:

In the event that all of the memberships of the Members of Messiah Fund are terminated, or the Delegates (defined below) otherwise determine that all of the Members are otherwise unaccounted for, then, in such event, the Delegates (defined below) shall promptly convene in person, by electronic conference, by teleconference, or by such other means as may be permitted by the Bylaws for the conduct of meetings, for the limited purpose of nominating and electing by majority vote at least one (1) and not more than seven (7) persons who are willing to serve as Members of Messiah Fund and who are otherwise qualified as provided herein. A quorum for purposes of such election shall be a majority of the Delegates.

**X. Additional Article:**

The Messiah shall be appointed as a Member as follows:

When Jesus Christ returns as Messiah, as described in Revelation 19:11-16, He shall be appointed as the principal Member, Director and Officer of Messiah Fund.

**XI. Additional Article:**

The qualification, number and duties of Delegates are as follows:

1. Qualifications. Delegates need not be residents of the State of Wyoming but must be of legal age. Delegates must agree to faithfully perform the duties of Delegates as specified herein. Delegates.

2. Number. The Members shall elect at least one (1) Delegate.

3. Duties. The sole responsibility of the Delegate(s) is to appoint new Members under the limited circumstances as provided herein.

**XII. Additional Article:**

Delegates shall be appointed or elected and their commission terminated or concluded as follows:

1. Appointment or Election. Delegates may be specified by the Incorporator in the organizational minutes of the corporation or elected by a unanimous vote of the Members.

2. Duration of Service. Each Delegate shall hold office until the expiration of the term for which he or she is elected and thereafter until his or her successor has been elected and qualified, or until such time that the Delegate is removed by vote of the Members, if earlier.

**XIII. Additional Article:**

Each Member, Director and Officer of the corporation must subscribe in writing to the following testimony as a qualification of office:

"I hereby believe, publicly declare and testify that Jesus Christ is the one and only Son of God and that, as God and Lord, Jesus Christ died on a cross for my sins, rose from the grave, lives forever, and will one day return as the Messiah, King of Kings and Lord of Lords." (In addition, during the time described by Jesus in Matthew

24 as "a great tribulation," the subscriber must further have rejected any mark required by any government or kingdom to be affixed in any form to his or her person, and further refused to worship any person or thing other than God as described in the Bible.)

The provisions of this Article shall not be amended except upon unanimous vote of the Members.

**XIV. Additional Article:**

The following distribution provisions apply:

The corporation's purposes include the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**XV. Additional Article:**

The following distribution limitation provisions apply:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation.

**XVI. Additional Article:**

The following limitations apply:

No substantial part of the activities of the corporation shall include the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities that are not otherwise permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**XVII. Additional Article:**

The following theological considerations apply:

The Incorporator may adopt in the organizational minutes of the corporation theological considerations that guide the corporation's Directors and Officers in carrying out the purposes of the corporation. Such theological considerations may be revised only upon a majority vote of the Members.
