NOTICE TO OUR DELEGATES

We appreciate very much your willingness to serve in the role of Delegates for Messiah Fund. The purpose of this Memorandum is to document formally and conveniently your duties and the considerations surrounding your duties as Delegates--adding details to what is already constituted in the Charter of the organization.

We acknowledge that you are not Christians and that you are offering to serve as Delegates of Messiah Fund solely as a matter of courtesy to us and solely for the limited purposes of Delegates as set forth in our Charter. We also acknowledge that you are honorable individuals, and that you have been selected to serve as Delegates primarily because of our appreciation for your reputation and the caliber of your legal expertise.

As Delegates, you have one (1) duty to Messiah Fund, and that is to elect new Members for the Messiah Fund in the event there are no members. As Article IX of the Charter, as it exists to date, provides:

In the event that all of the memberships of the Members of Messiah Fund are terminated, or the Delegates (defined below) otherwise determine that all of the Members are otherwise unaccounted for, then, in such event, the Delegates (defined below) shall promptly convene in person, by electronic conference, by teleconference, or by such other means as may be permitted by the Bylaws for the conduct of meetings, for the limited purpose of nominating and electing by majority vote at least one (1) and not more than seven (7) persons who are willing to serve as Members of Messiah Fund and who are otherwise qualified as provided herein. A quorum for purposes of such election shall be a majority of the Delegates.

As we discussed with you at the time of our invitation to you to serve as Delegates, we created Messiah Fund because we believe that an event, the Rapture, is prophesied in Scripture. We have more fully detailed in the Messiah Fund's website, <u>www.messiahfund.org</u>, many of the

considerations in Scripture regarding the Rapture, but it is essentially the gathering by Jesus Christ of all of His saints from the earth prior to the pouring out of God's wrath on the earth as promised in Scripture. Because the Members of Messiah Fund are "saints" (not by any moral goodness but solely by the credit of righteousness given to us as a consequence of our belief in the person, death and resurrection of Jesus Christ), we expect that we will be gathered to Jesus Christ in the Rapture. Accordingly, in the event of the Rapture we will all indeed become "unaccounted for" as described in Article IX, triggering your duty to elect new Members.

We believe that in the event of the Rapture, the world will suffer from a period of chaos as everyone tries to understand the reason for the sudden departure of so many people. We believe that great departure will likely affect stock markets, real estate markets, supply chains, transportation, education, the insurance industry, court systems and government assemblies, because people from every walk of life will suddenly disappear. The movie series *Left Behind* endeavored to capture the devastation of such an event in film. Notwithstanding the chaotic time, we ask that you act with diligence and dispatch to get new Members elected at that time.

We also believe that in the event of the Rapture, many people who did not, prior to the Rapture, believe in Jesus will recognize that the Rapture (as so many Christians believed and as discussed in Messiah Fund's website) indeed happened, and they will be incited by the Rapture to become followers of Jesus Christ. Such persons will become candidates for membership in Messiah Fund. Indeed, it is our hope that you, as Delegates, might even become candidates for membership of Messiah Fund.

In selecting new Members, you are guided by the following provisions of the Charter:

- Article VII Qualifications. Members need not be residents of the State of Wyoming but must be of legal age. Members must be recognized as persons who advocate Jesus Christ, who have been generous in their giving to religious and charitable causes, and whose reputation is such that they could be trusted to faithfully advance the mission of the corporation. Members must subscribe to the Testimony as set forth in these Articles. The provisions of this Article shall not be amended except upon unanimous vote of the Members.
- Article XIII Each Member, Director and Officer of the corporation must subscribe in writing to the following testimony as a qualification of office:

"I hereby believe, publicly declare and testify that Jesus Christ is the one and only Son of God and that, as God and Lord, Jesus Christ died on a cross for my sins, rose from the grave, lives forever, and will one day return as the Messiah, King of Kings and Lord of Lords." (In addition, during the time described by Jesus in Matthew 24 as "a great tribulation," the subscriber must further have rejected any mark required by any government or kingdom to be affixed in any form to his or her person, and further refused to worship any person or thing other than God as described in the Bible.) The provisions of this Article shall not be amended except upon unanimous vote of the Members.

We believe that immediately following the Rapture, the Great Tribulation will begin, so the parenthetical provision should, in such an instance, be deemed to apply.

• Of course, the persons selected must be willing to serve as Members of Messiah Fund.

We ask that you additionally instruct the newly appointed Members to search the organization's database (a) to obtain a listing of all donations expected via will amendments and charter amendments as a means to locate assets that are to be given to Messiah Fund, (b) to immediately retain lawyers and law firms as necessary to initiate proceedings to recover such assets, and (c) to use and/or liquidate the assets as necessary to promote the Gospel of the Tribulation period and to provide comfort and sustenance to saints who could subscribe to the above testimony and are subject to persecution for their faith.

As a final word to you, we ask that you please read the information provided on Messiah Fund's website regarding the Great Tribulation period. The world is about to be judged by God, and saints are about to be persecuted by a prominent world leader (who Scripture describes as the antichrist). You see that we were right about the Rapture, so you can be confident that we are right about the devastation to come. We plead with you to embrace "to the end" the Gospel of the Tribulation, which is encompassed by the Testimony set forth above.

Thank you for your service. While we know that you do not necessarily appreciate it, we ask God to bless you for providing this necessary service to Messiah Fund.
